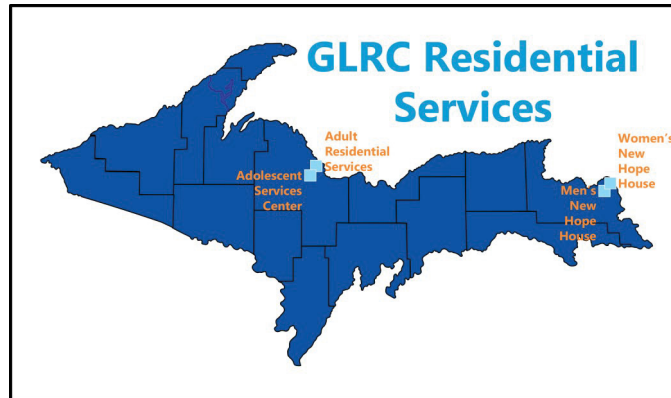
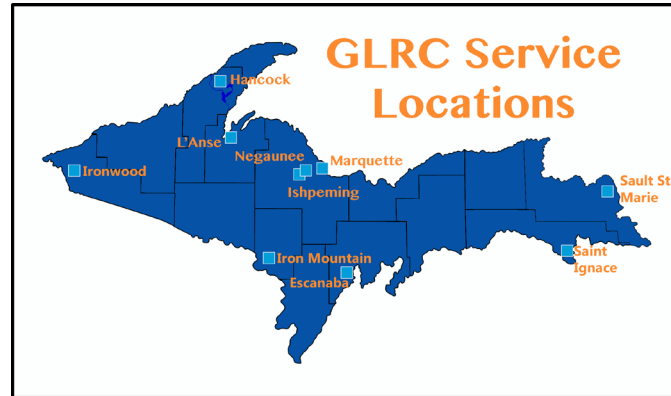

Substance Abuse Services

Outpatient Services

Great Lakes Recovery Centers (GLRC) has nine outpatient services offices across the Upper Peninsula. Outpatient services are the first option for those who need the freedom to continue working or attending school and are used as follow-up for those clients who have completed residential services.

Adult Residential Programs

GLRC has three residential centers for adults, one in Marquette, and two in Sault Ste. Marie. Residential treatment allows clients to live in a therapeutic environment, alongside other clients with 24-hour supervision and access to on-site clinicians.

Residential treatment usually includes an assessment of physical and mental health, coordination of medical services, individual therapy with a designated counselor, an individualized treatment plan and transitional planning.

Adolescent Services Center

Adolescent Services Center (ASC) provides residential treatment for youth between the ages of 12 and 17. ASC believes in a holistic approach to substance abuse treatment and works individually with each client to create a personalized plan with a variety of evidence-based substance abuse and relapse prevention materials.

A year-round classroom is taught by a state certified teacher who meets each child's educational needs. Clients take part in weekly recreational activities, community service projects, gardening and much more.

In addition to individual and group counseling, ASC clients also take part in family therapy, music therapy and equine therapy. Residents have the opportunity to express themselves through various means such as art, photography, Native American programs, meditation, yoga, faith-based counseling, and more.

AcuDetox

The adult residential facilities, along with a number of outpatient offices offer AcuDetox as another pathway to recovery.

Social Detox

All three of the adult residential services sites offer Social Detox services to medically stable clients as they withdraw from alcohol or drugs. Extensive monitoring and care is provided for these clients.

Women & Family Services in Residence

Women's New Hope House in Sault Ste. Marie has specially furnished suites to accommodate clients with dependent children up to age 11. School aged children are bussed to school, while on-site care is provided for younger children. Parenting classes are offered for mothers with children of all ages.

Women & Family Services

Women & Family Services provide specialized case management by a certified Women & Family Specialist for all clients in Marquette County. This casement addresses housing, legal issues, finances, education, medical referrals, and parenting classes. The program is designed to help meet the unique needs of women in the Substance Use Disorder treatment setting.

Group Therapy

A variety of outpatient groups are held weekly at many of our Outpatient Services Offices.

Recovery Housing

GLRC offers recovery housing for women in Marquette and L'Anse and recovery housing for men in Sault Ste. Marie. This provides structure, support, and a safe environment for individuals living in recovery.

Other Services

GLRC offers a wide variety of behavioral health services. Some of these services include:

Foster Care

GLRC's MDHHS Regional Resource Team provides information about becoming a foster parent, supports current foster parents, and provides comprehensive training to those interested in becoming foster parents.

Medication Assisted Treatment

GLRC's Medication Assisted Treatment clinic provides a combination of counseling services and medication that can help control cravings and the chemical impacts of substances.

Medical Services

GLRC is now offering general health and women's specialty care services.

Offender Success

GLRC works with returning parolees in the UP to assist with transition back into the community.

Prevention Services

GLRC facilitates both substance abuse and suicide prevention programming throughout the UP.

Trauma Assessments

GLRC partners with Easterseals of Michigan to provide trauma assessments to children ages 1-18.

Veterans Services

GLRC offers weekly support groups for veterans, as well as residential access.

Mental Health Services

Mental Health services are offered in a number of our outpatient services locations. Clinicians are trained to recognize and personalize a treatment plan for adults, adolescents and children troubled by anxiety or depression, stress conflicts or relationship difficulties, trauma or abuse (PTSD), attention, conduct and educational issues, and other mental health disorders.
