


# Recovery Housing

## About Recovery Housing

Recovery housing provides structure and support for those living in recovery and allows a safe environment for individuals to continue to heal from the impacts of addiction. Staff are committed to helping residents gain life skills, make healthy decisions, and strengthen their recovery. Residents attend group meetings, individual counseling, and weekly case management sessions.

Often, after completing residential treatment for substance use disorders, clients return to the same living situation that had supported their addiction, and are faced with the same challenges and temptations they had before. Many of these environments are toxic. While clients have changed during treatment, their living environment has not. This is why recovery housing can be an effective support program in the continuum of care for behavioral health services.

## Admission Criteria

- 18 years of age or older
- Be able to live in a shared living environment
- Attend four self-help meetings weekly (NA, AA, SMART Recovery, etc.)
- Obtain full-time (32+hr/week) employment within 60 days
- Participate in weekly chores
- Attend weekly house meetings
- A minimum of 30 days in recovery prior to applying to Recovery Housing
- Rent will be 30% of gross income; alternative payment arrangements may be discussed.

# Other Services

GLRC offers a wide variety of behavioral health services. Some of these services include:

## Outpatient Services

GLRC currently has eight outpatient services offices across the Upper Peninsula. The availability of clinicians and services are different at each location, please call the Access Center at (906) 228-9696 to inquire about services near you.

## Residential Services

GLRC has three residential centers for adults and the only residential treatment center for adolescents with Substance Use Disorder in the UP.

## Medical Services

GLRC is now offering general health and women's specialty care services.

## Offender Success

GLRC works with returning parolees in the UP to assist with transition back into the community.

## Veterans Services

GLRC offers weekly support groups for veterans, as well as residential access.

## Peer Support

Peer Recovery Coaches are able to assist the client with community based support and services, along with advocating for client needs, and assisting the client to integrate into the community. Peer Recovery Coaches offer flexible scheduling and offer accessibility to clients outside of typical business hours.
